Czech National Trust in 2015

INTRODUCTION

The year 2015 was, in many respects a turning point for the Czech National Trust (CNT). By setting up public collections, we have started a long-term support for projects to restore historical monuments, furthermore we are developing our charitable work and are actively working together with volunteers. We organize events for the public and devote a lot of energy to raising awareness abroad about Czech culture.

Thanks to clearly defined goals and international significance of our activities, we have been able to engage followers from all over the country as well as abroad. The best example is our pilot project, but there are also other initiatives, which started as a one-off activity but are already becoming well established. A good example of this is the specialist seminar within the programme Pilgrimage Days in Crisis which was attended by Crispin Truman, CEO of the Churches Conservation Trust in 2015, the most important British organisation involved in taking care of sacral buildings. The "Working Holidays" programme got off to a good start – a programme for volunteers which is traditionally organized by National Trusts around the world wherby groups of people get involved in the restoration work on historical or natural monuments and at the same time get to know the culture of their host country. Thanks to our good cooperation with the British National Trust, the CNT "Working Holidays" programmes are advertised internationally which helps to raise awareness of Czech cultural heritage and Czech hospitality all over the world.

Another major achievement in 2015 is the establishment of the Czech National Trust Abroad (CNTA), an independent charity that raises funds and supports the Czech National Trust activities in the UK and elsewhere abroad.

However, the most important event of 2015 is undoubtedly the acquisition of the first ever property into CNT ownership, thanks to the generous donation of 2 hectares of land by the Hlavnička family, which allowed us to start fulfilling all our goals and start implementing the pilot project.

Activities in 2015

VOLUNTEERING

CNT organises hands on involvement of volunteers in projects to preserve and restore places of cultural heritage. In 2015 we successfully initiated the long term "Working Holidays" project aimed at international volunteers when we welcomed participants from Great Britain. Two one week programmes were organised during the summer months with the support of our local team members.

CHARITY ACTIVITIES AND FUNDRAISING

Pilot project

The reconstruction of the Tomb and Chapel of the writer Marie von Ebner-Eschenbach in Zdislavice near Kromeriz was selected as the CNT pilot project.

German-language writer of Czech origin Marie von Ebner-Eschenbach is considered one of the most important literary figures of the 19th century. Household name in Austria, practically unknown in her homeland. By restoring the tomb in her native village of Zdislavice CNT wants to draw attention to the connection and will commemorate the 100th anniversary of her death in 2016.

Notable Classicist tomb with a beautiful chapel is located in the village of Zdislavice in the Kromeriz district. The place is admired for its technical and architectural solutions, the unique atmosphere and sensitive incorporation into the terrain with long-distance views of the landscape.

We are raising funds for the reconstruction and restoration of the interior of the tomb, chapel and furniture. In cooperation with the Zlin region, Museum of Kroměříž and the Moravian Museum we are preparing a series of events to commemorate the centennial of Marie von Ebner-Eschenbach in 2016.

In 2015 the land of approx. 2 hectares surrounding the building of the tomb and chapel was donated to the Czech National Trust (CNT) by its original owners, Jose and Robin Hlavnicka.

In 2015 the first phase of reconstruction was successfully completed – structural reinforcement was designed and implemented by the Zlin Region in cooperation with the Czech National Trust and with the support of grants from the Czech Ministry of Culture. CZK 900,000 of the total amount of CZK 4,025,000 was covered by the Program for preservation of architectural heritage 2015 and the remaining amount of CZK 3,125,000 was funded by the Zlin Region.

Immediately after the Czech National Trust took ownership of the land work commenced on clearing overgrown vegetation – manually as well as by using machinery.



Business Report

FOR THE PERIOD 1.1.2015 - 31.12.2015

Report was carried out by the company Daně a účto, s.r.o., registered office Jánská 25, 767 01 Kroměříž, IČ:28268725.

The corporate income tax return for 2015 was prepared by Ing. Monika Šestáková Schillingová MBA, tax advisor reg. no. 1622.

Key business operation of the organisation:

The business result of the organisation's main operation is a loss of CZK 183 374.91.

The key source of income for the organisation in 2015 was the donation of the property, i.e. the land including the building without a post code in the community of Troubky-Zdislavice. The value of the property was estimated by an expert (reg. no. 10 068-98-15) to be CZK 288 770.00.

The most significant income of CZK 150 425.85 came from donations towards the organisation's key activity.

Further income of lesser amounts were CZK 5 663.23 from currency exchange and CZK 539.09 from interest.

All the income was used in accordance with the founding documents and the purpose of the organisation's operation. On 31.12.2015 the balance in cash and in the bank accounts is CZK 1 004 023.79.

The organisation's liabilities to suppliers total CZK 2 321.00 and to others arising from statutory liability insurance, social and health insurance, income tax and a liability to an employee totalling CZK 22,089.00

Given the obligation to use the financial donations solely to finance the main activity, these revenues did not enter the corporate tax base. Amounts of financial free income used for non-tax deductible expenses were deducted from these revenues in the tax return. The application of the reduction of the tax base pursuant to $\frac{920}{7}$ of the ZDP for public benefit taxpayers in the amount of CZK 16,000.00, the tax liability of the organisation is zero.

The profit and loss account and balance sheet can be found in separate annexes to this annual report.
