## Czech National Trust in 2016

#### **INTRODUCTION**

The year 2016 was a significant and very successful year for the Czech National Trust (CNT). During the year we organised three weekly volunteer working holiday programmes as well as several weekend working parties in which 40 volunteers put in an incredible thousand hours of work. All this effort made a big difference – a place which was in a neglected state only a year ago has become an interesting destination on a network of tourist hiking and cycling trails and a very pleasant location, attracting visitors not only from nearby but also from abroad.

In addition to the ongoing work on the pilot project, we continue to systematically develop our activities also abroad, mainly thanks to the work of our sister organisation, Czech National Trust Abroad based in London which aims to support, fundraise and promote CNT and Czech cultural heritage abroad. The proof of the success of our efforts is securing the support of major sponsors who enable us to implement our projects: such as company Sigma, which has supported our activities from our inception and more recently, the Avast Foundation has made a significant contribution towards the restoration work of the pilot project.

Our charity activities continued in the form of organising public collections through which we have been supporting projects for the restoring of historical monuments. Active work with volunteers this year enterd a new phase, when we began to work intensively on the restoration of the historic park in Zdislavice, which we received last year as a gift from José and Robin Hlavnicka.

In 2016 our efforts gained a new momentum - by free transfer of the tomb with the chapel from the Zlín Region, we managed to consolidate the original historical land in Zdislavice into the ownership of the CNT. A very important moment was that the Zlin Region carried out the static security of the building and thus paved the way for further reconstruction of the monument, which will be completely under our control. The ceremonial opening of the project took place in the presence of the Czech Minister of Culture Daniel Herman, the Austrian Ambassador to the Czech Republic Alexander Grubmayr and other prominent guests. We also received a congratulatory letter from his Royal Highness English Crown Prince Charles, who is the President of the British National Trust and wishes to be kept informed of our achievements.

We are also pleased to have established the CNT Prague Group, which is preparing new projects in and around Prague and is a very important step towards expanding the volunteer base without which the activities of the Czech National Trust could not exist.

The year 2016 was a proof that cultural heritage is a very important and attractive topic for a large group of people of all ages who, with our help can take part in its restoration. We are extremely pleased that our projects appeal to the public all around the world and thus increase interest in the historical heritage of the Czech Republic.

## Activities in 2016

#### **VOLUNTEERING**

The CNT organizes active involvement of volunteers in cultural heritage conservation and restoration projects. In 2016, we significantly developed a long-term project of international Working Holidays volunteer programmes, which was attended by a total of 20 volunteers from the United Kingdom, USA, Ireland, Norway, Czech Republic and Slovakia. In the course of the year we organized three such stays, each lasting a week involving the participants in the preservation and restoration the park surrounding the pilot project in Zdislavice. Each volunteer worked 30 hours a week and collectively they put in 600 hours clearing and restoring the park.

In addition, we organised 4 intensive volunteer working days using equipment provided by our sponsors - 40 volunteers put in 400 hours of work.

Since June 2016, we have been maintaining the park grounds by using the Starjet Goliath mulcher which had been loaned to us by the Seco GROUP, a.s. from Jičín.

As part of the volunteer service, the tomb with the chapel in Zdislavice has been opened to the public since spring 2016. In 2016, 300 visitors have enjoyed guided tours around the monument.

## Pilot project

Throughout 2016 we worked intensively on the pilot project to build a memorial to the writer Marie von Ebner-Eschenbach in Zdislavice. Several working parties took place during which volunteers put in nearly 1,000 hours. The parkland is regularly maintained and is open to the public all year round. The tomb and the chapel were made accessible as part of weekend guided tours, special events and on request for expert visits and tours.



The full restoration work on the building and in the park was made possible once the Zlín Region transferred the ownership, free of charge, of the tomb and the surrounding land to the Czech National Trust.

In November 2016, we received a grant of CZK 1,000,000 from the Avast Foundation to repair the stone elements and the railings of the terrace. Preparatory work started immediately, implementation will be by 31.12.2017.

#### WORK CARRIED OUT ON THE PILOT PROJECT IN 2016:

- manual and machine clearing of approx. 3/4 of the 2 ha area -
- regular mowing and restoration of the grassland areas
- eradication of invasive plant species (Japanese knotweed)
- · arboristic treatment and safety remediation of woody plants by a professional company
- building an information panel board with a seating area
- designating a new tourist trail with a detour signage to the park and the tomb (Czech Tourist Club)
- securing the terrace around the tomb with temporary railings
- securing and protecting the original floor in the chapel with a protective walk-on cover
- professional repair and replacement of the rain gutters
- istallation of information panels both indoors and outdoors

## **Business Report**

## FOR THE PERIOD 1.1.2016 - 31.12.2016

Report was carried out by the company Daně a účto, s.r.o., registered office Jánská 25, 767 01 Kroměříž, IČ:28268725.

The corporate income tax return for 2016 was prepared by Ing. Monika Šestáková Schillingová MBA, tax advisor reg. no. 1622.

### Key business operation of the organisation:

The business result of the organisation's main operation is a loss of CZK 552 822.44

A major contribution to the organization's activities in 2016 was a grant of CZK 1,000,000 received from the Avast Foundation for the reconstruction of the terrace and a wheelchair access to the tomb and chapel of Maria von Ebner Eschenbach. Accordingly, the grant was not kept in the accounts as a part of the income, but sits directly in a separate account of the accounting group 90- equity or capital - where its drawing will be monitored separately.

Other income from donations towards the organisation's key activity amount to CZK 198 544.81 and have been posted directly to specific funds. From these funds, CNT provided a donation to the National Monument Institute (NPU), a state contributory organisation, in the amount of CZK 122 000.00, intended exclusively for the restoration of the Chinese pavilion in the chateau garden in Kromeříž and also drew for specific purposes - tomb maintenance.

Further income of smaller amounts were CZK 9 176.00 as an operating grant the Zlin Region, CZK 18 000 for the hire of the space for a cultural event at the tomb and CZK 1 520.00 from the sale of the publication about Marie von Ebner-Eschenbach.

On 31.12.2016 the balance in cash and in the bank accounts is CZK 1 386 075.81. This amount includes the donation contribution of CZK 1 000 000.00

The organisation's liabilities to suppliers total CZK 7 645.00 and to others arising from statutory liability insurance, social and health insurance, income tax and a liability to an employee totalling CZK 16 118.00.

Given the obligation to use the financial donations solely to finance the main activity, these revenues did not enter the corporate tax base, but were accounted for in accordance with ČÚS no. 413 *Own resources*, into the individual funds and their utilisation was charged to exempt revenues. All the income was used in accordance with the founding documents and the purpose of the organisation's operation.

Amounts of financial free income used for non-tax deductible expenses were deducted from these revenues in the tax return. The application of the reduction of the tax base pursuant to  $\S 20/7$  of the ZDP for public benefit taxpayers in the amount of CZK 16 000.00, the tax liability of the organisation is zero.
