Privacy Policy

Czech National Trust

The Czech National Trust, o.p.s. ("**Operator**") processes all personal data exclusively in accordance with the applicable legal regulations governing the protection of personal data, i.e. Act No. 110/2019 Coll. (on the Protection of Personal Data) ("**Act**") and EU Regulation No. 2016/679 (General Data Protection Regulation), which in some respects replaces the Act ("**Regulation**").

With this declaration, we inform about the processing of personal data that occurs in connection with a visit to our website, as well as about other cases of processing of personal data where the activities of the operator involve the processing of personal data of other persons.

Processing of log files

In the context of access to its website, the operator processes log files on access to this website in order to protect its legitimate interests in ensuring the protection of the website and improving its functioning.

The processing of these log files will be carried out by the operator; the operator processes the following data, which may (but need not) include personal data of the website visitor:

- the website from which the visitor visited the operator's website;
- IP address:
- date of access and time of access;
- the visitor's query, if any;
- the response code http;
- information about the browser and operating system of the visitor's computer.

Use of cookies and website analysis

In order to improve the functioning of its website, to evaluate its traffic and to optimise marketing activities, the operator uses cookies on its website. Cookies are small text files that are stored locally by the browser on the computer used to view the website. Cookies do not serve to and do not allow the personal identification of website users. In the event that a visitor to the website does not consent to the collection of cookies, he or she can prevent their collection by changing his or her browser settings.

Processing of personal data in connection with the handling of complaints, enquiries and other actions

In order to answer queries, handle requests and process other actions addressed to the operator, the operator will process the personal data provided by the person who raised the query or request. The operator will process the personal data provided in this way only to the extent necessary (provided) and only until the query or request is processed, unless there is a need to process the personal data for another purpose (for example, to protect the rights and legally protected interests of the operator). These personal data are provided to the operator voluntarily, as without their knowledge the operator would not be able to process the enquiry or request and therefore the processing is non-consensual.

Scope of processing of personal data

CNT processes personal data provided to it by the donor or collaborator via the registration form or by other means, e.g. by telephone, in writing. The personal data processed may therefore include in particular:

 Personal data: name and surname, e-mail address and, if provided by the donor or collaborator, home address, telephone number, bank account number, individual contribution payments, and, in connection with electronic access to the website, IP address, cookies.

Purpose of processing personal data

The personal data of donors or collaborators are processed to ensure their proper participation in the support of CNT, i.e. in particular their registration, processing and matching of donations made by them and communication with donors or collaborators, including the issue of receipts for income tax purposes. Thus, within the scope of this processing purpose, the processing of personal data will take place in particular:

- identification of the donor or collaborator and his/her donation according to and to the extent of the data provided by him/her, so that the donor or collaborator can follow how his/her donation has been handled,
- for internal communication with the donor or collaborator (e.g. sending newsletters, automatically generated alerts, thank you and other messages and issuing receipts for income tax purposes), on the basis of the consent to the processing of personal data given to CNT by the donor or collaborator or his/her legal representative, and
- in connection with the performance of CNT's legal obligations, as they are or may be provided for by Czech and/or EU law; or
- where necessary to protect the rights and legal claims of CNT (under the Act) or for the purposes of the legitimate interests of CNT or other persons (under the Regulation); again, legitimate interests under the Regulation may include, in particular, the protection of the rights and legal claims of CNT.

In some cases, certain personal information may be used for CNT's public presentation and marketing activities to existing or potential donors or collaborators, or to the public, to encourage donor or collaborator participation and to obtain funds for distribution to recipients.

Sources of personal data

The personal data processed are obtained from donors or collaborators, in particular in connection with the donor's or collaborator's registration with CNT and, where applicable, in the context of other communications with donors and collaborators, whether in person, by telephone, in writing or otherwise, and from other documents and documents provided by the donor or collaborator to CNT.

Other personal data protection rights

The processing of personal data by the Operator does not involve decisions based solely on automated processing that would have legal effects or otherwise significantly affect the data subjects whose personal data the Operator processes pursuant to this Privacy Statement. The data subjects whose personal data are processed by the operator are entitled to the following rights in relation to the processing of their personal data, provided that the conditions set out in the legislation are met:

- the right of access to personal data, consisting in the right to receive, free of charge upon request, information on which of their personal data the operator processes;
- the right to have their personal data processed corrected;
- the right to have their personal data processed erased;
- the right to restrict the processing of their personal data:
- the right to the portability of personal data;
- the right to withdraw consent to the processing of personal data at any time, provided that consent is the legal basis for the processing of personal data

concerned (i.e. for the sending of newsletters and other advertising communications).

Furthermore, data subjects whose personal data are processed by the operator have the right to object to the processing of their personal data if the legal basis for the processing is the legitimate interests of the operator, subject to the fulfilment of the conditions laid down by law.

The aforementioned rights, as well as complaints, may be exercised by data subjects whose personal data are processed by the operator in writing or by e-mail to the operator as data controller, using the contact details set out in Article 11 below.

Withdrawal of consent to the processing of personal data

The provision of consent to the processing of personal data is always voluntary and the donor or collaborator has the right to withdraw their consent at any time, in whole or in part. Consent may be withdrawn on www.czechnationaltrust.org (i.e. in the manner in which it was originally given), or by written notice sent to CNT's registered office address or its email address as listed above. From the date on which the withdrawal of consent is notified to CNT, CNT may only process personal data to the extent that it has another legal ground for processing, i.e. in particular for the performance of its legal obligations or for the purpose of protecting rights and legal claims as described above.

FURTHER INFORMATION ON RIGHTS IN RELATION TO THE PROCESSING OF PERSONAL DATA

In addition to the rights already mentioned above, the Act and the Regulation also grant to persons whose personal data CNT processes the rights summarised below.

The right to access personal data under the provisions of Section 12 of the Act: if a data subject requests information about the processing of his/her personal data, CNT is obliged to provide him/her with this information (which always includes the information under Section 12(2) of the Act) without undue delay.

Protection of rights under Section 21 of the Act: Any subject who discovers or believes that the Controller is processing his or her personal data in a way that is contrary to the protection of the subject's private and personal life or contrary to the law, in particular if the personal data are inaccurate with regard to the purpose of their processing, the subject may ask the Controller or processor for an explanation or demand that the Controller or processor remedy the situation (in particular by blocking, correcting, supplementing or destroying the personal data).

According to the Regulation, the data subject has in particular the following rights: **The right of access to personal data:** The data subject has the right to obtain confirmation from CNT as to whether it is processing his or her personal data and, if so, to obtain access to that personal data.

The right to rectification or erasure or restriction of processing: the data subject has the right (in the cases provided for in the Regulation) to request CNT to rectify or supplement incorrect or incomplete personal data, to request the erasure of personal data

if the reason for processing it has ceased or is no longer applicable, or to request restriction of the processing of personal data in connection with the resolution of the circumstances of the processing of personal data by CNT.

Right to object: The data subject shall have the right, on grounds relating to his or her particular situation, to object at any time to CNT to the processing of his or her personal data processed for the purposes of the legitimate interests of CNT or of other persons (as defined in the Regulation); legitimate interests under the Regulation may include, in particular, the protection of CNT's rights and legal claims.

Right to data portability: the data subject has the right (subject to the conditions set out in the Regulation) to obtain his or her personal data from CNT and to transfer it to another data controller.

Right to lodge a complaint with a supervisory authority: A data subject has the right to lodge a complaint with a supervisory authority if he or she considers that the processing of his or her personal data has infringed the Regulation. This supervisory authority will be the Office for Personal Data Protection for data subjects residing in the Czech Republic.
