

Conditions of the CNT-INTO Places card

1. The Club CNT is a program of active support for the activities of the Czech National Trust (CNT). CNT is a member of INTO – an international network of national heritage trusts, which brings together organizations that protect the cultural heritage of our planet.
2. With your support, you are helping CNT with the preservation of monuments, historical objects, gardens, natural and cultural landscapes in Czech Republic for future generations. At the same time you now have an exclusive opportunity to use the unique INTO Places program – an INTO project supporting the preservation and development of monuments and cultural heritage, by making these unique heritage sites around the world more accessible.

How? With the CNT-INTO Places Card.

3. Any natural person who meets the following conditions can obtain a CNT-INTO Places card:
 - Permanent residence in the Czech Republic
 - Age over 18 years
 - Support for CNT activities in the amount of at least CZK 2,500 per year.
4. Those interested in the CNT-INTO Places Card apply via electronic application – by sending the form available on the website www.czechnationaltrust.org/into-places
5. For conditions regarding legal entities, write to intoplaces@czechnationaltrust.org.
6. After verification that the conditions have been met, the CNT-INTO Places Card will be sent to the address given to the interested party. The offer is limited until the CNT-INTO Places Card capacity is exhausted. There is no legal right to the provision of the CNT-INTO Places Card.
7. During the period of validity, the CNT-INTO Places card allows its holder and one other person to use the benefits of the INTO Places program, under very favorable conditions or completely free of charge (depending on the currently valid INTO and INTO Places conditions) to visit sites under the management of participating INTO members around the whole world.
8. An overview of participating INTO members, specific accessible sites, exact visiting conditions and other information on the INTO Places program can be found on the website www.into.org/places, on the local websites of individual INTO members, in whose territory the selected sites are located, and on the websites of the relevant properties made available. Always check that information is up-to-date before visiting; the conditions and rules of entry may change over time depending on the agreement with individual INTO members (national trusts) or on the current preferences of the owners or administrators of the participating sites.
9. CNT or the Club CNT is not the provider of the INTO Places program and cannot influence or guarantee in any way the continuity or scope of the benefits of the INTO Places program for holders of the CNT-INTO Places Card. Possible changes to the scope of benefits, their limitation or cancellation of the INTO Places program do not entitle the holder of the CNT Places Card to a refund of any support provided.
10. The CNT-INTO Places Card is non-transferable, benefits can only be drawn by its authorized holder, i.e. the person in whose name the CNT Places Card is issued, for the period indicated on the CNT-INTO Places Card, usually for the duration of the calendar year for which it was issued.
